This MEMORANDUM OF UNDERSTANDING (MOU) is made on the

23<sup>rd</sup> Day of December 2020.

BETWEEN

**P. C. Solution**, a private concern having its trade license bearing number : 4298, under Raniganj Municipality, having its office situated at A/23, NSB Road, Balaji Enclave, Raniganj 713358, providing sales & services on computers, its peripherals, software and hardware, of the FIRST PART,

AND

**Raniganj Girls' College**, P.O. : Searsole Rajbari, - 713358, Dist.- Paschim Bardhaman of the SECOND PART. WHEREAS both the parties of the FIRST PART and SECOND PART have come to an understanding to engage themselves for 5 (Five) years from the date of agreement in the following mutually helpful ways in respect of proper,

Scientific and environment friendly e-waste management through handing over of obsolete electronic goods like computers, UPS, TV, laboratory based electronic apparatus etc. by Raniganj Girls' College to the FIRST PART and providing equivalent amount of necessary services by P. C. Solution to the college, which includes annual maintenance and services of computers, LAN maintenance, Software installation and Chip level repairing etc., the extent of service to be delivered being strictly determined by the cost of the obsolete e-materials being handed over by the College (SECOND PART) to the FIRST PART (P. C. Solution).

The Services of P.C. Solution comprise of the following:

- Servicing of Computers
- Servicing of Printers
- LAN maintenance
- Software installation
- Chip level repairing etc.

**Jurisdiction:**

If at any time any dispute, difference or question arises between the parties out of or in relation to the construction, meaning or effects of this MOU or any clause herein contained or the rights and liabilities of the parties hereto, and the same cannot be settled mutually, every such dispute, difference or question shall be settled by arbitration adjudicated by a sole arbitrator mutually agreed upon by both the parties and the decision of the arbitrator will be final and binding on both the parties. The seat of such arbitration shall be Asansol and disputes, if any, shall be under Asansol jurisdiction only.

**Termination:**

Either party shall have right to terminate the same on mutual agreement with a valid cause by giving 90 days' notice.
