MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

Raniganj Girls' College, Searsole Rajbari, District: Paschim Bardhaman, West Bengal, India, PINCODE: 713 358

AND

Dr S Maji, Physician, Raniganj

FOR

Providing periodic on campus health check-up and clinical facility free of cost to the regular students of Raniganj Girls' College

This Memorandum of Understanding (hereinafter called the MoU) is entered into on this 25th day of August Two thousand and twenty.

Raniganj Girls' College, Searsole Rajbari, PINCODE: 713 358, District: Paschim Bardhaman, West Bengal, India constituting the FIRST PARTY, hereinafter referred to as "the college"

AND

Dr Subhendu Maji, Physician, Raniganj, PINCODE: 713 347, District: Paschim Bardhaman, West Bengal, India constituting the Second Party, hereinafter referred to as "the doctor"

with reciprocal consent mutually agrees upon the following clauses:

**Clause I:** The doctor will provide voluntary medical service by conducting weekly health check-up and clinical assessments of the regular students of the college on a fixed day every week.

**Clause II:** The medical service will be provided free of cost by the doctor.

**Clause III:** The college will provide necessary space as required for medical examination of the students.

**Clause IV:** The scope of health check-up and/or medical service to the students will be restricted within the limits of assessing the health condition of a student and providing free medical advice and the service provided by the doctor and the college will EXCLUDE diagnostic testing (pathology, radiology etc.) and supply of medicine.

**Clause V:** The MoU will remain in force for a period of five years beginning on the date of execution of this MoU.

**Clause VI:** The MoU may be terminated by either of the parties unilaterally, provided a prior intimation is served to the other party at least ninety (90) days in advance.

In full agreement upon the aforementioned clauses we solemnly put our hand and seal on this indenture of Memorandum of Understanding
