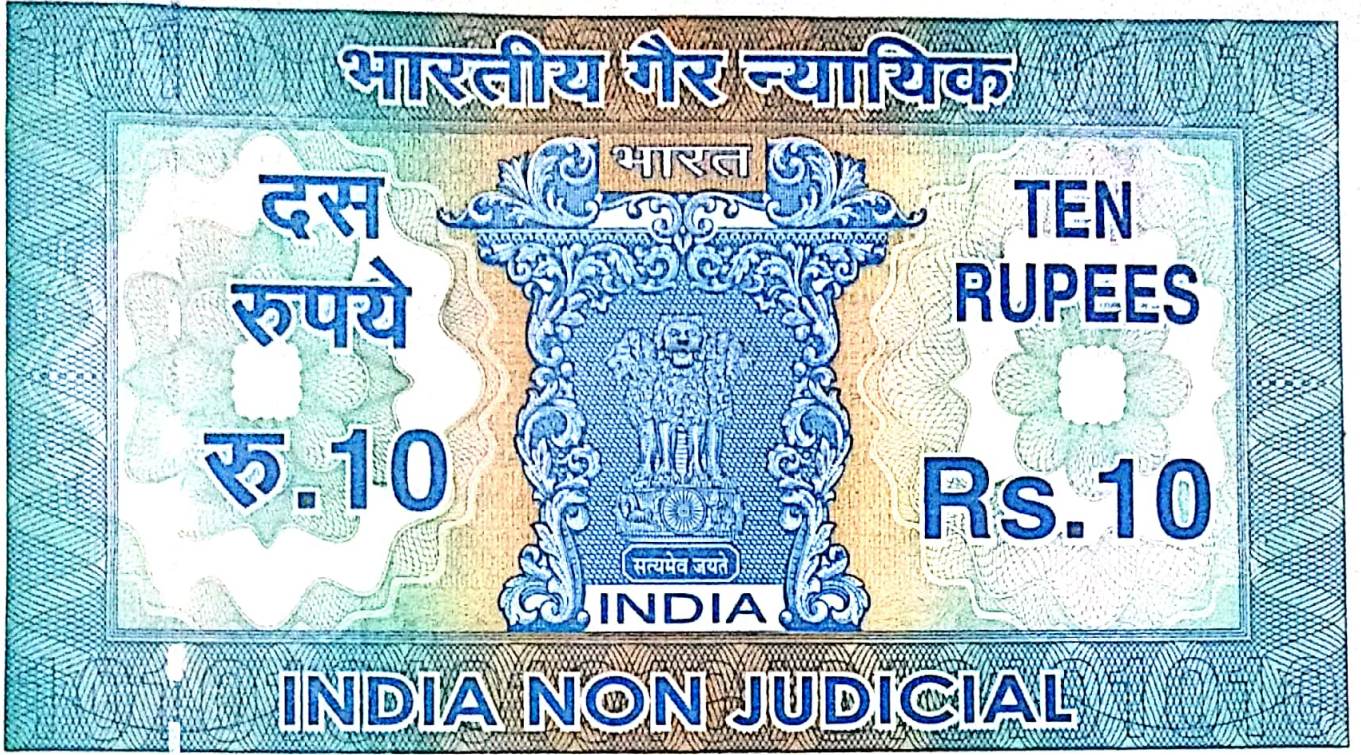

Next Generation Scientist Private Limited, Lucknow, UP, India, THE SECOND PARTY represented herein by its Name of Competent Authority / Representative

PURPOSE OF MOU

In particular, this MOU is intended to

1. Exchange Academic Knowledge and information
2. Exchange of Technical Experts and Information
3. Mutually receive Educational visits by Faculty Members and Researchers
4. Conduct Joint Research Projects
5. Conduct of Short-Term courses related to Bio-informatics for the academic development of the students.
6. Organize various workshops
7. Conduct practical trainings
8. Generate self-employment opportunities
9. Assist the students in establishing various start-ups
10. Assist the placement of trained students
11. The institution will set up its BioScience Excellence Centre in the college.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause: 1

CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the First Party.

Clause: 2

SCOPE OF THE MOU

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
- 2.2 The Second Party will give valuable inputs to the First Party in teaching/ training methodology so that the students fit into the industrial scenario meaningfully.
- 2.3 The interaction between Next Generation Scientist Private Limited and Raniganj Girls' College will give an insight into the latest developments/requirements of higher studies; the Second Party to permit the Faculty and Students of the First Party to visit its institution and also involve in workshop for the First Party. The industrial training and exposure provided to students through this association will build confidence and prepare the students to have a smooth transition from academic to working career.

Clause: 3**VALIDITY**

- 3.1 The validity of the agreement is five year from the date of agreement.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
- 3.3 Any dispute will be settled under the jurisdiction of the Asansol Court.
